Zafar has a broad practice that spans all of Chambers' main areas of practice and in particular employment, sport, investigations, public/regulatory and human rights. Recent highlights of Zafar's practice include:

- his appointment, in June 2021, as one of four Commissioners on the Independent Commission for Equity in Cricket (ICEC), set up by the England and Wales Cricket Board to investigate issues of inequality and discrimination in the sport. The ICEC's Report 'Holding Up a Mirror to Cricket' was published in June 2023;
- acting for the Open University in a 15-day trial defending a claim of harassment, direct discrimination, victimisation and constructive unfair dismissal by an academic with gender critical beliefs (led by Jane Mulcahy KC);
- his secondment to the UK energy regulator OFGEM between October 2022 and April 2023;
- acting unled in successful disciplinary and safeguarding proceedings brought by UK Athletics;
- acting for a family of a man seeking disclosure from The National Archives of police files concerning his unsolved racist murder (led by Tom Hickman KC);
- conducting highly sensitive investigations into allegations of race discrimination, breaches of confidentiality, unfair recruitment processes, and victimisation (assisting Gemma White KC and David Pievsky KC).

Prior to commencing practice, Zafar played professional cricket for Surrey and England. After retiring from the sport in 2017, Zafar worked as a youth advocate at the charity Just for Kids Law, assisting young people with understanding and claiming their rights in areas including, but not limited to: community care, education, housing, immigration, and criminal justice. Whilst undertaking his legal qualifications, Zafar also spent time volunteering for the Refugee Council and the charity Inquest.

Zafar assisted Catherine Callaghan QC who acted for the Appellants in this appeal concerning the scope of the ET's power to prohibit the disclosure of information under Rule 50 of the ET Rules of Procedure. The Appellants made an application to prohibit the disclosure of certain information in ET proceedings, relying on all three limbs of Rule 50, namely, the interests of justice, Convention rights and confidentiality. The Appellants successfully argued in the EAT that the proposed derogation from the open justice principle was necessary to protect the safety and security of non-participants in the litigation located outside the UK, in a country that was not a signatory to the ECHR.

#### **Disability Discrimination Claim**

Successfully argued that the Claimant was a disabled person at all relevant times for the purposes of s6 of the Equality Act 2010.

#### **Advice on strike out (unfair dismissal and discrimination)**

Advised a claimant bringing a number of employment-related claims (including unfair dismissal and disability discrimination) on the prospects of successfully applying to strike out the respondents' defence on the basis of alleged witness intimidation.

### **Advice on the application of a settlement agreement**

Advised a law firm on whether the terms of a previous settlement agreement prohibited the firm from representing future potential claimants in employment-related claims.

A claim for judicial review concerning the lawfulness of the withdrawal of regulatory accreditation granted to solar photovoltaic generating station, which enabled the station to claim renewable obligation certificates (assisting Hanif Mussa).

[2021] EWHC 2233 (Admin)

A claim for judicial review concerning whether the omission to make further provision in legislation to assist blind and partially sighted voters in time for the general election in December 2019 breached human rights (assisting Hanif Mussa).

**R (JS) v Secretary of State for the Home Department**

A claim for judicial review of the Secretary of State's ongoing decision that parents and siblings of refugee children are not entitled to family reunion on the same basis as the spouses and children of adult refugees under the Immigration Rules (assisting Jason Pobjoy).

**All the Citizens v Prime Minister**

A claim for judicial review concerning the UK Government's decision not to order an investigation into Russian interference in the UK's democratic processes during and after the EU Referendum in the 2016, and the adequacy of the UK's legal framework with respect to protecting the electoral process from foreign state interference (assisting Jason Pobjoy).
