### **XL Insurance Co SE v IPORS Underwriting Ltd**

[2021] EWHC 474 (Comm)

Commercial Court claim to restitution of allegedly overpaid income tax raising “interesting and potentially difficult issues” regarding the bona fide purchase defence to equitable proprietary claims (and analogous defences to personal claims in unjust enrichment). The reserved judgment of Cockerill J noted Ajay’s “highly skilful submissions” on behalf of HMRC.

### **Pleshakov v Sky Stream Corp & Ors**

[2021] UKPC 15

Acted (with Barbara Dohmann QC and Barnaby Lowe) for the Second and Third Respondents to a Privy Council appeal from a decision of the Eastern Caribbean Court of Appeal. The appeal concerned issues regarding the creation of bare trusts, the distinction between bare trustees and nominees, and the ability to run an allegedly new case before a final appellate court.

Acting for Ofcom in four related Part 8 Claims, and appeals to the Court of Appeal, in respect of over £200 million in licence fees levied under regulations held to be ultra vires, concerning counterfactual defences to Woolwich claims in unjust enrichment. ## Financial Services & Banking

Ajay is ranked as a leading junior in financial services. He has acted for and against the regulators in a number of the leading financial services enforcement cases in recent times, as is evidenced by the Parliamentary and national press attention that these cases have often received. For example, he acted for one of the successful appellant lenders in the landmark Supreme Court motor finance appeal; he successfully acted for one of the former senior managers of HBOS (the FCA and PRA decided to take no action after a six-year investigation); and he is currently acting for the FCA in the ongoing proceedings concerning Carillion plc. He frequently appears as an advocate in front of the FCA's Regulatory Decisions Committee and has been instructed in numerous regulatory judicial reviews.

In 2015-16, Ajay was seconded to the Enforcement Division of the Financial Conduct Authority for seven months. He advised on a wide range of investigative and sanctioning powers and enforcement policy issues.

## Cases

### **Rangecourt SA (formerly Banque Havilland) & Ors v FCA**

[2026] UKUT 00047 (TCC)

Ajay acted for the FCA in this three-week substantive reference hearing. The Upper Tribunal upheld the FCA's case that Rangecourt SA (formerly Banque Havilland) and two of its former employees (Edmund Rowland and Vladimir Bolelyy) acted without integrity in respect of a document prepared at the bank's offices in 2017 setting out a strategy involving market manipulation. The Tribunal determined that significant fines should be imposed (£4m, £352,000 and £14,200 for Rangecourt SA, Mr Rowland and Mr Bolelyy respectively) and upheld the FCA's decision to ban Mr Rowland and Mr Bolelyy from working in financial services. David Rowland, the Honorary President of the Bank, made a third-party reference disputing a few of the findings made about him in the FCA's decision notices; the Tribunal found that there was insufficient evidence in relation to most of those disputed findings but his references were nevertheless dismissed. The Tribunal's judgment addresses among other things the test for what amounts to a firm's "business" under Principle 1 (see [502]-[545]) and also the test for corporate attribution under Principle 1 (see [546]-[571]). FCA Final Notice, October 2025

Acted for the FCA in its successful appeal to the Court of Appeal in this landmark regulatory case which concerns (i) the FCA's powers to impose requirements to pay redress on individual firms (in this case a requirement said to amount to \$700m arising out of an alleged failure properly to manage conflicts of interests); and (ii) the Upper Tribunal's jurisdiction to permit amendments to the FCA's case after the issuance of a statutory notice and/or during Tribunal proceedings (with Andrew George KC and Ava Mayer). Acted for HMRC in this tribunal appeal by an investment fund manager against HMRC's refusal to refund output tax charged on the services it provided to funds whose investors were charities, Church of England entities and a local authority.

## **Link Fund Solutions**

FCA Final Notice, April 2024

Acted for the FCA in its enforcement action against Link Fund Solutions (LFS). The FCA found that LFS failed to act with due skill, care and diligence in its management of the Woodford Equity Income Fund (WEIF). The LFS final notice confirms the failings which led to the FCA's investigation and subsequent agreement from LFS to settle the enforcement case and provide compensation to those affected. Those invested in the WEIF when it was suspended are starting to receive a share of the up to £230 million redress scheme, which was approved by the High Court in February 2024. [2023] UKFTT 856 (TC)

Appeal by the taxpayer against a decision of HMRC to treat IT services supplied to the bank as standard rated for VAT purposes. Ajay appeared for HMRC with Kieron Beal KC and Andrew Macnab.

## **Financial Conduct Authority v Carillion Plc (In Liquidation)**

[2021] EWHC 2871 (Ch); [2022] Ch 162

Acted for the FCA in its successful appeal to the High Court establishing that the FCA does not have to obtain the court's permission under the Insolvency Act 1986 s130(2) before issuing warning notices against a company in liquidation pursuant to the Financial Services and Markets Act 2000 ss.91 and 123.

**FCA and PRA v Senior manager of HBOS**

(2022)

Ajay successfully acted for a former senior manager of HBOS in defending the regulatory enforcement proceedings brought by the PRA and FCA. Following a six-year investigation, the regulators' decision-making committees decided to take no action in August 2022. The FCA's press release is available here. **R(T and another) v FCA**

**Interactive Brokers (UK) Limited**

FCA Final Notice, January 2018

The Financial Conduct Authority (FCA) imposed a financial penalty on Interactive Brokers (UK) in the amount of £1,049,412 for failings in its post-trade systems and controls for identifying and reporting suspicious transactions. Ajay acted for FCA Enforcement and presented the case to the Regulatory Decisions Committee.

**R (We Fight Any Claim Ltd) v Financial Conduct Authority**

[2017] EWHC 2264 (Admin)
